Applications must include: completed registration packet; recommendation letter from your Fire Chief; proof of FF I & II (Pro Board) and FI I & II certifications; 3+ years of demonstrated FI experience. No exceptions will be made.



Upon successful completion of all portions of the course, candidates will receive Pro-Board Live Fire Instructor / Instructor In Charge certifications.
