



Fire Instructor II - 123 tests


Fire Officer I - 58 tests




CERTIFICATION MANUAL

Should a candidate fail an exam, they have one (1) year within the most recent NFPA standard change to retest and will be eligible to test a total of three times. The candidate must wait 30 days before a retest can be granted. The retest may be scheduled by submitting a request to the Certification Manager at the MFSI office. [pg. 19 in MFSI Certification Manual, updated 2024]

RECORD SCANNING PROJECT UPDATE

MFSI has scanned thousands of Maine firefighters' training records into a dedicated drive, fulfilling its responsibility to maintain copies of issued certifications under state law. Additionally, copies are backed up on the Pro Board certification registry and SMCC's secure database, ensuring the safety and accessibility of these records. Individuals looking to obtain a physical copy of their certificates on file can make a request and pay a \$10 processing fee, or at no cost request an electronic delivery.






