Myself, part of MSFO Class of 2001, remain in contact with many fire service leaders from my academy class: Chief David Groder - Augusta Fire Department, Chief Darrell White - Presque Isle Fire Department, Lt. Gerry Gay - Sanford Fire Department and the PFFM, Lt Harold Smith - Sanford Fire Department, Lt. Francis (Rick) Johnson - Rockland Fire Department (Retired) and MFSI Deputy Director, Jim Roy. As of now, MFSI will host one (1) Fire Officer II Academy per year and conversations to bring a Pro Board Fire Officer III are ongoing.



County Representatives are MFSI Instructors who attend county meetings and report on localized fire training news and training demands. This intel is very important to MFSI as it provides additional information to inform priorities and further both instructor and program development.

FREQUENTLY ASKED CERTIFICATION QUESTIONS

"I just completed a Fire Fighter I & II program. When can I expect my certificate?"

Please give MFSI's Certification Office 30-45 days for processing. The clock starts once all progress charts have been received from the Program Coordinator and upon successful completion of exams.

"Who do I talk to regarding replacement of certificates?" Contact Deputy Director Jim Roy at MFSI.

"If I fail my exam, when can I retest? How many attempts do I get?"

Should a candidate fail an exam, they have one (1) year within the most recent NFPA standard change to retest and will be eligible to take the test a total of three times. The candidate must wait 30 days before a retest can be granted. The retest may be scheduled by submitting a request to the Certification Manager at the MFSI office.

"I want to take a BPOC or EVDT certification course. Where can I find one?"

Begin by networking with neighboring departments. While MFSI does send instructors to BPOC/EVDT courses, many of the program deliveries are in-house and very localized.
