“Flash Point” Team Building Seminar: Ignite Your Team & Forge A Winning Culture”

Keynote Speaker: Deputy Chief Frank Viscuso, Leadership & Team Building Specialist

Paul served as a rescue officer and structural collapse technician instructor on FEMA's USAR MATF-01 and was a founding member and Operations Chief for RI's state USAR team.

Paul has a bachelor's degree in Fire Science from Providence College, He also has a law degree from Roger Williams University School of Law and a certificate from Harvard Law School's Labor and Worklife program.

Paul's legal practice focused on labor and employment law for the past twenty years before his retirement. He recently authored a chapter in NFPA's 2023 edition of the Fire Protection Handbook "Understanding and Addressing Discrimination and Harassment in the Fire Service." Paul has extensive experience teaching fire ground, technical rescue, and legal subjects throughout the country in-

cluding at FDIC, Firehouse Expo, and many state and local fire conferences. His presentations for the Fire Law Group, www.firelawblog.com now focus on fire service liability, discrimination and conducting workplace investigations.

Chief Shawn Esler, Maine State Fire Marshal

Shawn Esler served as the Waterville Fire Chief for 6 years and worked for the department for 16 years before being recently appointed by Governor Mills to become the new State Fire Marshal this past October. Esler currently serves as Deputy Chief for the Albion Fire Department in addition to his new role.

Rebecca Graham, MMA Senior Legislative Advocate

Rebecca Graham started working for the MMA advocacy team in 2017. Rebecca received her BA degree from the University of Southern Maine Humanities & Global Studies and Master of Laws, (LL.M) in International Human Rights Law and Transitional Justice from the University of Ulster's Transitional Justice Institute, and (GCert) in EU Migration Law from The Global Campus of Human Rights in Venice, Italy. Rebecca also works in democratic governance evaluation, in former Soviet states, with the Organization for Security and Cooperation in Europe (OSCE) which assists states in their transition to strengthen and rebuild their democratic institutions, public safety and security and rule of law governance structures with cultural and gender sensitivity. She and her family have long standing service in public safety professions, including her sons who serve as volunteer firefighters in their communities. Rebecca's areas of advocacy are criminal justice, environment and natural resources, agriculture, inland fisheries, marine resources and insurance.

Chief William Gillespie

As a 38-year veteran of the Fire Service and legislative liaison for the Maine Fire Chiefs for the past six years, Chief William Gillespie has dedicated himself to driving positive change within Maine's Emergency Services. Through collaborative efforts with state representatives, he has successfully garnered support for key initiatives, resulting in significant funding allocations. Notably, these efforts have secured over \$3 million for training facilities, \$2 million for the Length of Service Award Program to benefit emergency personnel in their retirement years, and \$1.5 million towards health and wellness initiatives, including cancer and cardiac screenings.

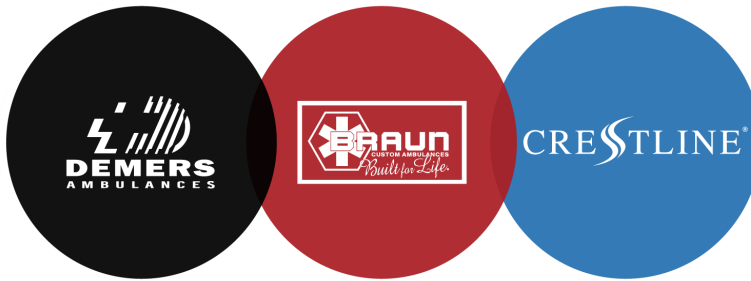
